



### **INSTRUCTIONS FOR MARCH OF DIMES FUNDRAISER MAIL IN ORDERS**

If you would like to send us your order by mail and pay by check, money order, bank check / debit card, or credit card, please follow these instructions:

1. Go to the March of Dimes Products Page on our web site: [www.awarenessproductsonline.com/marchofdimes](http://www.awarenessproductsonline.com/marchofdimes)
2. Click on the "Fundraiser Section"
3. Add the items you want to your "Shopping Cart"
4. Once you have completed adding your products to the Shopping Cart page, add your zip code and click "Calculate Shipping"
5. Select the method of shipment you want from the drop down menu
6. Click on "Check Out"
7. On the Check Out page, either type in your information or print this page and write in your information
8. All orders being shipped to California must include 8.75% sales tax
9. PRINT OUT your CHECK OUT page (Please make a copy for your records!) and mail this in with your payment for the total amount to:

- All fundraising profits from the re-sale of the March of Dimes products must be delivered to your local March of Dimes Chapter office. To locate your local Chapter office, please go to [www.marchofdimes.com](http://www.marchofdimes.com) and enter your zip code.
- Orders are not shipped until complete. If we are currently out of stock of one or more of the items you are ordering and do not want to wait until your order is complete, please place individual orders for backordered items. - Credit cards are charged and checks are processed at the time the order is received.
- If you pay by check, your cancelled check is your receipt.
- There is a \$25.00 charge for returned checks.
- If an order is returned to us due to an insufficient or incorrect mailing and / or ship-to address which you provided, you will be notified and asked to provide and / or verify your mailing or shipping information and asked if you would like your order reshipped. If you request your order to be re-shipped, the prevailing shipping rate plus \$3.50 will be charged to your credit card or you will be asked to send in a check to cover these costs before it is re-shipped.
- FedEx will not deliver to a Post Office Box.
- If you provide an accurate e-mail address, a FedEx tracking notification will be e-mailed to you when your order has shipped.
- Please add 8.75% to all orders being shipped to California.
